2019-20 HOCKEY SEASON

JUNIOR VARSITY TEAM FINANCIAL RESPONSIBILITY AGREEMENT

By accepting a position and being rostered on the Deer Lakes Hockey Club (herein called DLHC) Junior Varsity team, we the undersigned are accepting financial responsibility for the 2019-20 hockey season. This includes the fee of **\$1250.00**, and other monies that may be due for additional activities for the team. If for some unforeseen reason my child is unable to continue playing or chooses to leave the organization at any point during the season, **we will be responsible for payment equal to the total amount of the outstanding balance for the season at the time.** It is further understood that, until this amount is paid in full or an amicable solution is agreed to by both parties, the DLHC **will not release** our child to play for any other USA Hockey organization, including an amateur team. It is also understood that all players must provide their USA hockey registration, obtained at their own expense, before they can be added to the roster.

Payment Structure for the 2018-19 season will be as follows:

**A non-refundable commitment fee of \$100.00 that will be applied toward your financial commitment to the team but if at any time subsequent to registering for the team you decide not to play, this commitment fee will NOT be refunded under any circumstances.*

1. All payments are due by the 15th of the month with the last payment made no later than December 15th, 2019.
2. Make checks payable to: DLHC and dropped off in the club mailbox at Frozen Pond Arena or mailed to our PO Box address. If you need to request different arrangements, you must contact the President and Treasurer directly for consideration and approval.
3. ALL PLAYERS are required to purchase a home and away game jerseys, and coordinating socks. This is the only uniform that is permitted to be worn for games.
4. The DLHC maintains the right to prohibit players from participating in any on ice activities including both practices and games if payments become delinquent at any time. This policy WILL be strictly enforced. At any time an account is more than (30) days past due, and payment arrangements have not been secured with the treasurer, the strict "No pay, No play policy" will be enforced.

We have read and understand our financial responsibility to be rostered on a DLHC Hockey team for the 2019-20 hockey season. By signing this Financial Responsibility Agreement we acknowledge and agree to the financial responsibilities as described above. We further understand that if our child leaves the DLHC we are responsible for payment equal to the total amount of the outstanding balance for the season at the time.
